- to undertake, in the event of being awarded a PNRR PhD scholarship ( ex Ministerial Decree n. 117/2023 or 118/2023), the withdrawal from the doctoral course entails the return of the monthly amounts received in the semester in which the withdrawal was presented, except for periods already completed, or according to different ministerial provision;
- the candidate declare not being holder of other scholarships awarded for any reason whatsoever not to benefit from any other grants or fellowship, and to undertake, for the entire duration of the scholarship funded under the PNRR PhD scholarship, does not take advantage of other scholarships awarded for any reason
