



EXPRESSION OF INTEREST

Selection based on qualifications and interview for the awarding of two 4-month contracts to sector experts for the development of educational materials, to be assigned to the Research Unit "Intelligent Technologies for Health and Wellbeing: Sustainable Design, Management and Evaluation" – Departmental Faculty of Engineering at Università Campus Bio-Medico di Roma, as part of the project "Health Technology: from capacity building to capacity strengthening – Afya Moja", TNE23-00079, scientific coordinator Prof. Leandro Pecchia, CUP C84C24000190006 (code MI_14_25).

Considering the project titled “Health Technology: from capacity building to capacity strengthening” – Afya Moja – TNE23-00079, under the responsibility of Prof. Leandro Pecchia, CUP C84C24000190006, funded within the framework of the National Recovery and Resilience Plan (PNRR) – Mission 4 – Component 1 “Enhancing the provision of education services: from early childhood to university” – Investment 3.4 “Advanced university teaching and skills”, Sub-investment T4 “Transnational initiatives in education”, funded by the European Union – NextGenerationEU.

Considering the financial coverage provided by the funds from the project titled “Health Technology: from capacity building to capacity strengthening” – Afya Moja – TNE23-00079, under the responsibility of Prof. Leandro Pecchia, CUP C84C24000190006.

Considering the Resolution of the Chief Executive Officer and General Director No. 41 dated August 5, 2025, a call for expressions of interest is hereby announced for the assignment of 2 contracts, each with a duration of 4 months, to sector experts for the development of educational materials.

ADMISSION REQUIREMENTS

Specific requirements:

- Master’s Degree in Biomedical Engineering (LM-21),
- Master’s Degree in Mechanical Engineering (LM-33), or an equivalent or legally recognized degree;
- Proficiency in English (minimum B2 level).

Preferred qualifications:

Experience in the design and production of educational materials in the field of biomedical engineering. All requirements must be met by the application deadline stated in this notice.

ACTIVITIES COVERED BY THE ASSIGNMENT

The duties of the contract include:

- Designing and producing educational materials in English in the field of biomedical engineering;
- Participating in coordination meetings with the project team;
- Adapting content to the formats required by the project;
- Supporting the linguistic and technical review of produced materials.

FINANCIAL TERMS

The contract will have a duration of 4 months, extendable until the end of the project, is stipulated free of charge and includes coverage of travel expenses up to a maximum of € 1500,00 and living expenses up to € 3000,00 per month for each assignment.

APPLICATION PROCEDURE AND DEADLINE

In the application, the candidate must declare under their own responsibility, pursuant to Articles 46 and 47 of Presidential Decree 445/2000:

1. **Full personal details** (name, surname, place and date of birth, tax code, residence and mailing address for communications, postal code, phone number, and email address);
2. **Citizenship**;
3. **Declaration of possession of the required academic degree**;
4. Declaration of equivalence **for foreign degrees**;
5. Request for recognition of equivalence to the Selection Committee (**for candidates with foreign degrees not yet recognized as equivalent** – must include a certified translation of the degree in Italian or English, and transcripts with grades);
6. Declaration of **English language** proficiency level.

The candidate must also declare:

- a) Enjoyment of civil and political rights;
- b) No criminal convictions;
- c) Authorization for the processing of personal data in accordance with Article 13 of EU Regulation 2016/679.

The following must be attached to the application, in PDF format:

- Curriculum vitae (dated, signed at the end, and initialed on each page), suitable for research activities;
- Any publications and additional qualifications, along with a list.

The University reserves the right to verify the accuracy of all declarations and documents submitted.

SELECTION COMMITTEE

will be appointed at the end of the notice period by the Chief Executive Officer and General Manager and will be published on the website of the Campus Bio-Medico University of Rome, in the Competitions-Expressions of Interest section at the link <https://www.unicampus.it/ateneo/concorsi/manifestazioni-di-interesse>.

The Committee may use online collaborative tools.

EVALUATION OF QUALIFICATIONS AND INTERVIEW

During the first meeting, the Selection Committee will define the criteria for evaluating candidates' qualifications.

The interview will focus on the candidate's past research, technical and professional skills, as well as on the project's specific topic and activities.

The interview will take place on: 24th October 2025 at 2:00 p.m.

Candidates will be interviewed online via Microsoft Teams. They must be available at the indicated time and date. For identification purposes (under penalty of exclusion), each candidate must present a valid ID before the interview begins.

RANKING

The Selection Committee will allocate a total of **100 points** as follows:

- Evaluation of qualifications, work experience, knowledge, and professional skills: up to **40 points**;
- Interview: up to **60 points**.

To be considered eligible, candidates must score a minimum of **70/100**.

A merit ranking list will be drawn up in descending order of total score and the successful candidate identified. The ranking list will remain valid for two years from the date of publication on the University website.

APPOINTMENT AND OBLIGATIONS OF THE SUCCESSFUL CANDIDATE

The ranking will be approved by resolution of the CEO and General Director and published on the University's website.

Before signing the individual contract, the selected candidate will be invited by the relevant office to submit the required documentation.
