# CALL FOR SCHOLARSHIPS FOR STUDENTS ENROLLED IN THE FIRST YEAR OF BACHELOR'S AND MASTER'S DEGREE COURSES OF THE CAMPUS BIO-MEDICO UNIVERSITY OF ROME A.Y. 2022/2023

#### **GENERAL INFORMATION**

This document only translates the call for proposal issued by the Rector's Decree on 17<sup>th</sup> April 2023 no. 332. The Italian version is the official document regulating this call. The document written in English language has no legal value. In case of conflicting issues between the English and the Italian version, the Italian version prevails.

The Campus Bio-Medico University of Rome grants scholarships based on income and academic merit, dedicated to students who are enrolled in the first year (2022/2023 a. y.) of the Bachelor's, Master's and single cycle Degrees of the University.

#### The scholarship cannot be combined with:

- 1. Discolazio tutition fees exemption and disability waiver: students who are eligible for or have already won the Discolazio scholarships 2022/2023 a.y. and students who are entitled to full disability fees exemption are therefore excluded from this competition;
- other scholarship or partial exemption granted by the Campus Bio-Medico University of Rome and scholarship granted by other entities; students who are recipients of the previously stated-benefits may obtain the scholarship referred in this call only following explicit waiver of the aforementioned benefits.

Further cases of non-cumulation, other than those mentioned above, are regulated by the relevant legislation. Non-cumulation applies only to the 2022/2023 academic year.

The scholarship provided by the Agreement between the RUI Foundation and the Campus Biomedico University of Rome can be combined with the scholarship referred to this call.

# 1. APPLICATION REQUIREMENTS

This competition is open to students who are correctly enrolled in the 2022/2023 academic year <u>in</u> <u>the first year</u> of Bachelor's, Master's and single cycle Degrees of the Campus Bio-Medico University of Rome, by the date of the application submission.

In order to participate in the competition, under penalty of exclusion, it is necessary to submit <u>the certification of the ISEE - Indicator of the Equivalent Economic Situation - 2023, relative to the benefits for the right to education.</u>

Concerning the determination of the household composition, the indicator of the income situation and the calculation of the ISEE, this call refers to the DPCM on 5th December 2013 no. 159 "Regulation concerning the revision of the modalities of determination and the fields of application of the Indicator of the equivalent economic situation (ISEE)".

In order to participate in the competition referred to this call, it is necessary to have an ISEE - Equivalent Economic Situation Indicator (for the right to study) not exceeding € 45,000.00.

#### Income documentation for foreign students (EU and non-EU)

The income requirement (ISEE not exceeding €45,000) is calculated on the basis of the sum of the income earned in the country of origin in 2021 by each member of the household and 20% of the held assets on 31st December 2021, relating to the obtained value to the parameter of the equivalence scale, applied to the household in relation to the number of members and any increases. Foreign citizens who are not living in Italy must submit a consular declaration (Annex 1) concerning the economic and patrimonial condition. This documentation must be translated into Italian language by the Italian diplomatic authorities, competent for the territory. Income received on 31st December 2021 and foreign assets held on 31st December 2021 are valued at the average foreign exchange rate of the reference year, determined by law and expressed in euro.

Real estate held on 31st December 2021 is valued only in the case of buildings, and considered on the basis of the conventional value of € 500.00 per square meter. All foreign students are oblige to present the certification of the economic condition, under penalty of exclusion from the benefits, using the scheme shown in Annex 1.

#### 2. CRITERIA FOR THE RANKING FORMULATION

The student's merit is assessed on the basis of the academic results obtained at the end of the first semester of the 2022/2023 academic year (until February-March 2023 exam session).

The ranking is formulated in order of *descending joint score*, obtained from the sum of the following scores:

ECTS Coefficient (ECTS Coeff.) + normalized ISEE (ISEEN)

# ECTS Coeff = obtained ECTS/ max. number of ECTS

Obtained ECTS: number of achieved and recognised ECTS in the relative study plan Max. number of ECTS: maximum number of achievable ECTS on the basis of the relative study plan

**Please note:** extra-curricular activities or partial exams will not be taken into account to calculate the obtained ECTS.

# ISEEN= (Max. ISEE - Right to study ISEE) / Max. ISEE

*Max. ISEE:* € 45.000,00

Right to Study ISEE: ISEE amount, submitted by the candidate according to Art. 1 of the present call

In the case of a tied score, the student with the lowest value of the ISEE indicator, referred to art. 1 of this call, comes first; in the case of equal ISEE amount, the student with the highest ECTS coefficient comes first; in the case of further parity, the youngest student comes first.

# 3. APPLICATION SUBMISSION

The application must be submitted exclusively online by **19th May 2023**, by the e-learning page of the University accessible at the following address https///elearning.unicampus.it with personal credentials. After having logged in, it is possible to access the Dashboard section on the top left of the screen and then go to Rights To Study section, available among the University services (whereby during the first access you will be required to register without a password). On the page, the form "Announcement of call for scholarships for students enrolled in the first year of bachelor's and master's degree courses a.y. 2022/2023" is available for submitting the application together with the instructions for its compilation.

In order to participate, all the candidates must attach the <u>certification of the ISEE - Indicator of the Equivalent Economic Situation – 2023</u> to the online application.

The document attached to the online application must be renamed with the candidate's name and surname. Only one application can be submitted; in the case of more than one submitted application, the first one chronologically sent will be taken into account. Incomplete or unsuccessful applications within the deadline indicated in the art. 3 will not be taken into consideration.

# 4. FORFEITURE, REVOCATION AND SANCTIONS

In the case of false statements, according to D.P.R. on 28th December 2000 no.445, the student loses the right to benefit from interventions and shall be subject to administrative sanctions in accordance with the law in effect and lose the right to obtain other grants for the duration of studies.

Students who give up their studies or move to another University will lose their scholarship. In the event of forfeiture, revocation or renunciation by scholarship-awarding students, the grant shall be subsequently awarded, within the limits of the remaining amounts, to eligible students in order of ranking.
